The Government of Sierra Leone through the Ministry of Finance has received financing from the World Bank toward the cost of the Sierra Leone Economic and intends to apply part of the proceeds toward payments under the contract for Reconstruction of 1.8km of Roads at Leicester Peak and 1.4km of Roads at Tacugama.

1. The Sierra Leone Economic Diversification Project now invites sealed Bids from eligible Bidders for Reconstruction of 1.685km of Asphaltic Concrete Road at Leicester Peak and Rehabilitation of 1.4 km of Gravel Road and 58 space car parks at Tacugama with ancillary Drainage and retaining Wall Works over a period of six (6) months with twelve (12) months Defects Liability Period.
2. Bidding will be conducted through National Competitive Procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers- Procurement in Investment Projects Financing" Published July 2016, Revised November 2017, July 2018 and November 2020 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
3. Interested eligible Bidders may obtain further information from Sierra Leone Economic Diversification Project, Osman Tommy, osmantommy@sledp.info and inspect the Bidding document during office hours 0900 to 1700 hours at the address given below.
4. The Bidding document in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **Five Thousand Leones (5,000)**. The method of payment will be cash to the Administrative Assistant Sierra Leone Economic Diversification Project 35, Percival Street followed by a written application letter.
5. Bids must be delivered to the address below on or before 11:00am on 2nd November 2022. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on 11:00am on 2nd November 2022.
6. All Bids must be accompanied by a Bid Security of **One Million Six Hundred Thousand Leones (SLE, 1,600,000)**

7. All Bids must be accompanied by a Sexual Exploitation and Abuse (SEA) and/or Sexual Harassment (SH) Declaration. Management Strategies and Implementation Plans (MSIPs) to manage the following key Environmental and Social (ES) risks:
 - a. Sexual Exploitation, and Abuse (SEA) prevention and response action plan.
 - b. Traffic Management Plan to ensure access of through traffic for residents and other users and the safety of local communities from construction traffic.
 - c. Environmental and Social Management Plan
